## Practice Overview

Natasha is a commercial and chancery barrister who is frequently instructed as sole counsel in high value litigation. Her diverse practice includes commercial disputes, insolvency, professional negligence, property damage, real estate, trusts and wills. She regularly appears before courts and tribunals of varying levels and is accustomed to representing clients at trials which occur over the course of several days.

Natasha won the Bristol Law Society's "Barrister of the Year 2017" Award within approximately a year of tenancy. The judges were said to be "struck by her apparent maturity with her work". She was described as "an excellent lawyer and pleasant to deal with" and "one to watch". Within her first five months of tenancy she was successful in an application for permission to appeal and an appeal concerning errors of law and fact. She is also an accredited mediator and has undertaken numerous mediations and joint settlement meetings as counsel.

# Areas of Expertise

## Agriculture & Rural Affairs

Natasha has acted in many cases which required the application of her knowledge of commercial disputes, real property, trusts, wills etc. in an agricultural context. She is accustomed to dealing with expert reports in this field such as those of agricultural engineers and agronomists. Natasha has also delivered a seminar to members of the Agricultural Law Association.

#### Commercial

Natasha is particularly interested in commercial matters and she has extensive experience in this field. She is currently instructed as a junior to Guy Adams on a very high value commercial matter concerning new technology and emerging markets on an international scale.

She is instructed to act for a variety of clients from major financial institutions to international companies and individuals. She regularly acts in subrogated insurance claims concerning complex multi-party disputes and insurance matters generally, inclusive of coverage.

Natasha has acted in a significant number of contractual disputes (carriage, construction, consumer credit, equine, guarantees, hire agreements, NHS contracts, sale and supply of goods and services, technology etc.). She is frequently instructed in partnership disputes as well as corporate and personal insolvency matters. Natasha is also able to advise on a range of company law issues such as directors' duties, shareholder agreements and unfair prejudice. She was involved in a disclosure dispute concerning documents used in other proceedings in the Chancery Division, Companies Court regarding the Company Directors Disqualification Act 1986 and a company in liquidation which managed a fund in excess of £100m.

Natasha is regularly instructed in specialist matters such as banking, defamation, dishonest assistance, intellectual property and malicious falsehood. She was also instructed by the GLD's commercial litigation team as part of teams of senior and junior counsel in relation to multimillion pound disputes concerning Francovich claims and unlawful interference claims.

#### Banking

#### Insolvency

Natasha has a broad range of experience regarding corporate and personal insolvency disputes including applications and trials where the issues require knowledge of her other practice areas. She also accepts instructions in relation to international corporate law and insolvency.

When she was a pupil, Natasha attended the Court of Appeal in Davy v Pickering and others [2017] EWCA Civ 30 which concerned restoration to the register of a dissolved company.



#### Examples of Natasha's experience include:

- An application for disclosure of documents used in other proceedings in the Chancery Division, Companies Court involving the Company Directors Disqualification Act 1986 and a company in liquidation which managed a fund in excess of £100m.
- Applications for annulment of bankruptcy orders.

- Winding up proceedings.

## Insolvency

Natasha receives instructions across the spectrum of intellectual property law including copyright infringement, database rights, passing off and trademark infringement. These instructions range from advice on settling disputes pre-action through to representing clients at trial. Natasha's academic studies covered copyright law (including software and internet copyright), design rights, passing off, patents, trademarks and trade secrets at domestic and international levels.

## Construction & Engineering

Natasha is often instructed in professional negligence matters in relation to construction professionals (see Natasha's professional negligence CV for more details).

#### Examples of her experience include:

- Contra charges
- Contractual variations
- Defective foundations
- Defective works generally including quality concerns e.g. CWI, installation of fixtures and fittings, roofing, tree proximity, wall ties etc.
- Design flaws
- Latent defects
- Professional negligence matters relating to design, installation, valuation etc.

- Validity of pay less notices.

## **Court of Protection**

Natasha has extensive real estate, trusts and wills experience and has also been instructed in matters in these areas where the Court of Protection was involved.

## Recent examples include:

- Advising on prospects, best interests and authority to litigate in respect of beneficial interests in a joint bank account.
- Advising on potential claims involving litigants lacking capacity.
- Contested applications regarding appointment of health & welfare deputies and property & affairs deputies.
- Proceedings concerning alleged misappropriation of funds.

## Mediation

Natasha is an accredited mediator who is available for instruction in mediations in any field. She is a specialist commercial and chancery barrister who is accustomed to acting as sole counsel in high value litigation particularly



in relation to commercial disputes, insolvency, professional negligence, property damage, real estate, trusts and wills.

Natasha aims to provide the parties with a cost-effective means of resolving their dispute via open communication as an alternative to the expensive, adversarial nature of litigation. She offers an excellent level of client service and is noted for her ability to devise practical and innovative solutions which is a skill she also utilises as a mediator.

## Professional Negligence

Natasha has a wealth of experience in this field and has been instructed to represent claimants and defendants. She is often instructed in respect of subrogated insurance claims. Her practice focuses on legal professionals (solicitors and barristers), construction professionals (architects, builders, surveyors etc.) and financial professionals. These disputes often concern matters relating to Natasha's other practice areas, however she also advises on professional negligence disputes generally. Natasha has a solid understanding of insurance law principles and so is also instructed on coverage matters.

As a commercial and chancery practitioner Natasha is accustomed to dealing with multifaceted claims which involve breach of fiduciary duty and breach of trust in addition to making tactical applications such as those for disclosure of documents used in other proceedings. She undertook a 3-month secondment at RPC in which she advised on, and drafted various documents in respect of, solicitors' professional negligence claims. These involved a range of firms, including international firms, where the insurer client was one of the world's largest insurance and reinsurance companies.

#### **Construction Professionals**

- Failure to adequately complete planning applications.
- Failure to advise during execution of project designs.
- Failure to design an appropriate development scheme and to advise on various matters affecting the proposed development at numerous stages.
- Failure to recognise potential issues during surveys.
- Inaccurate valuations and HomeBuyers Reports.
- Latent damage.
- Numerous cases concerning defective works including claims regarding cavity wall insulation, construction near trees, installation of appliances as well as fixtures and fittings, roofing, lintels, wall ties etc.
- ▶ Validity of an award under the Party Wall etc. Act 1996.

#### **Financial Professionals**

#### Wills & Trusts

Natasha has extensive experience of wills, trusts and probate matters. She is regularly instructed as sole counsel on matters of significant value from pre-action through to trial or mediation. Natasha advises on all aspects of estate administration and is particularly familiar with applications to remove personal representatives and trustees.

Natasha represented the defendants in Sollis v Leyshon & Leyshon [2018] EWHC 2853 (Ch) which was a complex 3-day trial concerning breach of trust, duress, proprietary estoppel, resulting trusts, unconscionability, undue influence and unjust enrichment. She was instructed as junior to Leslie Blohm QC in respect of the administration of the estate of the late Barry Pring, a case which received national press coverage. This concerned a millionaire who died intestate in the Ukraine and the issue of forfeiture.
