- Cases of an intractable and/or complex nature
- Finding of Fact Hearings

Jack has successfully applied for and resisted applications for Non-Molestation and Occupation Orders both exparte and inter-parties at Final Hearing in cases which involve allegations of serious domestic violence and sexual abuse.

Jack also has experience of, and a particular interest in dealing with cases in the High Court which involve the recovery of absconding parents and missing children within the UK and outside of the jurisdiction. He has experience of obtaining third party disclosure orders, Location and Collection Orders, Tipstaff Directions, Wardship, and of committal proceedings. Jack is happy to provide advice by telephone at short notice in these cases.

Divorce & Financial Remedy

Jack has a particular interest in and significant experience of financial remedy proceedings, this having been the focus of his pupillage under Nick Miller. Jack is regularly instructed to attend first appointments, financial dispute resolution appointments, and final hearings. He also has recent experience of conducting appeals.

Jack's cases frequently involve complex business assets, trusts, inherited wealth, pensions, and foreign assets.
