Charles has considerable experience dealing with real estate matters including boundary disputes, landlord and tenant work (both residential and commercial), rights of way, restrictive covenants and registration at HM Land Registry.

His work also includes: disputes over land including traditional boundary disputes, restrictive covenants, rights of way and other easements. He was successful in the Court of Appeal in an action concerning the interaction of boundary agreements and section 2 of the Law of Property (Miscellaneous Provisions) Act 1989, landlord and tenant disputes, both residential (Springfield Investments v Bell [1991] Ì EGLŘ 115 CA) and commercial (Toms v Ruberry -[2018] 1 WLR 1138), matters relating to mobile homes and mobile home parks (Howard v Kinvena Homes (1999) 32HLR541), and applications to the Property Chamber of the First -tier Tribunal and previously to the Adjudicator (Mann v Dingley [2011] EWLandRA 2010_0582).

Christopher is a chancery and commercial specialist with particular emphasis in real property litigation (particularly in relation to easements, restrictive covenants and contracts for the sale of land) and commercial and agricultural landlord and tenant disputes. He also regularly advises on professional negligence claims, particularly in relation to claims against solicitors, accountants and tax consultants in relation to negligent conveyancing and tax advice as well as being a trained mediator.

Joss also acts in a wide variety of residential property matters including boundary disputes, claims under the Trusts of Land and Appointment of Trustees Act 1996 and claims for easements.

His recent caseload includes:

- C v G (2017) a dispute as to the effect of a local authority signing, but not exchanging, an engrossed counterpart lease.
- W v M (2017) a dispute arising upon the termination of a tenancy as to whether there had been an implied surrender and re-grant or whether the tenancy had simply been varied.
- D v B (2017) advised in relation to an application for a statutory lease renewal under the Leasehold Reform, Housing and Urban Development Act 1993. The case also considered the applicability of the principles of waiver and estoppel.
- H v W (2017) a two-day trial in which Joss successfully defended his clients in dispute with their neighbours, including, inter alia, a claim under the Protection from Harassment Act 1997.

Annie has experience across the breadth of property and real estate matters and her recent cases include:

- A two-day trespass trial arising in the context of the breach of a licence and including extensive expert evidence.
- A one-day possession trial to evict a tenant on the basis of breach of his tenancy agreement due to anti-social behaviour.
- Advising the respondent to an application to set aside the transfer of a property due to alleged misrepresentation, deceit, undue influence, unconscionability and mistake.
