#### Georgina Swinglehurst, Barrister, Call 2019

Before deciding to pursue a career at the Bar, Georgina was a professional dressage rider, a member of the Junior/Young Rider Great Britain Dressage Squads and was selected for the British Equestrian Federation Talent Squad. She was awarded the Jules Thorn Scholarship from Middle Temple and an Advocacy Scholarship from BPP to undertake the Bar course.



#### Beatrice Baskett, Barrister Call 2021

Beatrice joins our Personal Injury and Clinical Negligence teams. She is under the supervision of Robert Mills for Clinical Negligence and Benjamin Handy for Personal Injury. Prior to starting pupillage, Beatrice worked at RWK Goodman as a Paralegal in the Clinical Negligence team, where she gained insight and experience into a broad range of claims. #### Ben Harwood, Barrister Call 2022

Ben joins our Commercial & Chancery teams and will be under the supervision of James Pearce-Smith. Prior to taking the Bar, Ben was an Advocacy volunteer for the Legal Advocacy and Support Project at Bristol Law Centre for 2 years alongside his studies.
